2. Driver understands that the Demolition Derby is a dangerous event, and that the Driver runs the risk of bodily injury or death.
3. Driver, for himself, his heirs and assigns, affiliates, agents, employees and legal representatives, in good faith does hereby fully and unconditionally release and forever discharge the Releasees from any and all claims, actions, causes of action, suits at law or in equity, demands, judgments, damages and controversies that the Driver now has or ever has had or ever will have, whether known or unknown whether for personal injury, property damages, or other economic loss, emotional distress, punitive damages, or otherwise, resulting from, arising out of, or in any way related to his/her participation in the even described above.
4. This release shall be binding upon Driver and his or her heirs and assigns and shall inure to the benefit of Releasees and Releasees' successors, assigns, affiliates, agents, employees and legal representatives.
5. The Driver attests that this Agreement and Release is voluntarily made after ample opportunity to review the document and has signed this release as his/her own free act.
